

# The Cat Pretection Society of New South Wales 17th Annual Report 1st July, 1977

Dear Member,

This 17th instalment of a continuing stery is only an epitome of events for the period under review. If I were to set out a fraction of the selfless humane acts performed by our members I would need many more pages to let the words flow. It would give me great pleasure to dot the resume with so many names who deserve mention. But if I mention one—then the list becomes endless of those kindly, compassionate folk who have contributed to make the year a satisfying, rewarding and worth—while time in our short history. So I must confine mention of individuals to where necessity dictates. The year's work shows improvements in membership, finance, desexing, expansion and includes completion of the drawn-out Morris Estate. But one matter clouds the scene—the agony of non-completion of the Articles of Association.

VALE. During the year a sad event which, in the natural order of things, came to pass. Mrs. Mary Kay Cooper, the Founder and inaugural President of the Society passed away on 24th April, 1977. The name of Mary Kay Cooper will continue to live on in an appropriate feature within our Desexing Clinic when purchased - we hope this year.

FINANCIAL. That dirty word - inflation - gave main avenues of expenditure a push upward, with veterinary services top of the class; then postage, printing, stationery and rates all showed a lift. Creditwise sustained generous giving by members held subscriptions, Xmas and Winter Appeals at healthy levels; and that apple of our eye, the Clinic Appeal, was pushed past last year's record. The big lift in "Fund Raising Events" and "Down Memory Lane", with higher rental income makes the whole a satisfying and rewarding year. That new segment "In lieu of blossoms in a wreath" is helping an animal rather than withering on the vine (should you have a sad event - please give it thought). Compare the 1976 figures on the enclosed Financial Report.

MEMORANDUM AND ARTICLES OF ASSOCIATION. As mentioned in the preamble, this matter had dragged on since November, 1974, when the draft was practically complete apart from tidying up on some points. Despite appeal in Newsletters, no-one, - repeat - no-one displayed the slightest interest, could'nt care less. I gave the whole matter away in disgust after explaining on a number of occasions that this organisation does not really exist; it does not have the same rights as you, the reader, has at law. Yes, we come under the Charitable Collections Act and have a name - but then, finish - non event. We cannot in our own right, as The Cat Protection Society of N.S.W., hold in that name the title to real estate, shares, debentures and the wot not which will come our way when those who recognise our merit and subscribe to our ideals pass on. To hold such assets we go through a cumbersome, clumsy and expensive formula by appointing de facto owners (Trustees)

as with our Regentville property and the Kingsgrove property in the Morris Estate and again when we purchase the Clinic. I have explained before that once we become a Corporate body all these matters will fall into place. Mrs. E.B. Smith of Committee has plucked the dying embers from the fire and the matter is slowly proceeding with Mr. W. Graham giving it a prod along. However, even with approval by three government departments and the members. All this before we can borrow to complete purchase of THAT CLINIC.

MORRIS ESTATE. At last the final Act. Briefly, Miss Edna Morris passed away January, 1974, with Probate being granted in June of that year. An ambiguous section in the Will lead the Executor to approach the Court for interpretation, with the Society being joined as one defendant and residuary beneficiary. In September, 1975, Mr. Justice 1 land gave judgment in favour of the C.P.S. This brought an Appeal and a war of nerves over twenty one months with the Estate offering the C.P.S. 40% of the \$30,000 value of the Kingsgrove shop property, with them retaining the premises and rental income. On refusal the offer was increased to 50%, after which the Society made a counter offer of \$7,000 for the Estate to relinquish any further claim (if any) in the property. Eventually this was accepted if the C.P.S. paid the Estate further legal costs of \$900. Refusal on the latter brought capitulation by the Executor with the shop now being transmitted to our de facto owners (Trustees). Future income will be . devoted to the welfare of animals - for evermore. Rewarding and stimulating and brings that desexing CLINIC very close.

GENERAL MEETINGS. Attendance has been one of the highlights of the year with the Annual meeting in 1976 drawing 42. The November gathering saw 52 and the April assembly this year brought 57; all of which is very encouraging to Committee which conveys its appreciation to those who came together, showed their concern and expressed support for that desexing Clinic. Attendance at meetings is a yard-stick by which one can assess the enthusiasm and sincerity of members their support to a given policy. The C.P.S. as the "baby" in the humane movement, with such a sustained roll-up of mounting numbers,

FIELDWORK. This is a loose term used to cover all involvement other than desexing and embraces entrapment of wild (feral) cats and their offspring - a time consuming and difficult task. The rescue of stray and abandoned animals in turn brings the problems of housing, feeding, care and veterinary attention; then finding homes or, in some cases, humane disposal. The Society has no machinery to carry out this work. It has no staff, motor vehicles or premises, with all work being voluntary and carried out by members when their personal obligations allow. Much of the expense, such as many 'phone calls for each animal,

petrol, food, and a multitude of items, is absorbed by the individual as his or her's further contribution. These kindly folk are the backbone of our Society while others wring their hands and are critical that their special needs are not met instantly, and other organisations unload their obligations on to us. The workers - about 2% of our membership - carry on silently and efficiently doing their best -- and they are stretched to the limit and beyond. SO PLEASE find your own solution for those unwanted kittens you have allowed to see the light of day. AND REMEMBER - DON'T LITTER!

DESEXING. People sometimes ask why we advocate desexing of felines. Well, my experience, and figures available, teaches that 70 to 80,000 unwanted cats are put to death in the County of Cumberland annually. No-one knows for sure how many roam the streets, alleys, bushland and industrial areas foraging for scraps of food and fighting for survival. But it has been estimated that one unspayed female cat can increase he animal population by hundreds of thousands over ten years, assuming that they all lived; and one Tom on the loose can sire as many as 2500 kittens in a year up to two miles from his base. The C.P.S. is convinced that the establishment of low cost desexing clinics in the major population centres of the State can greatly reduce the untold thousands of unplaceable kittens which are fleoding their way into our community at a faster rate than they can ever be absorbed. So, in sterilising during the year 199 femals and 43 males we have prevented 242 felines reproducing and giving birth to a staggering number of offspring their progeny and issue without end. The increase over the previous year's total of 170, with inflation, nearly doubled expenditure. (See Income and Expenditure).

VIVISECTION. The reaction by the members at the April General Meeting to the question of experimentation as written up in the Newsletter of There was not one dissent that month was very definite and unanimous. from the condemnation of medical, veterinary and commercial sadistic exploitation of and experimentation on animals. All the considerable correspondence was equally so. Of course I did not expect any other responsive feeling. You see, our members are a cross section of humanity from all walks of life who differ on many things but they have one thing in common - that basic agitation of mind to protect an animal from the rottenness of their fellow humans. So, for strength, they join an organisation devoted to animal welfare for they question "should life and happiness be man's alone?". In their title most animal welfare groups have prime words such as "PROTECTION", "PREVENTION", "WELFARE", and the use of these words is to signify the intention of those who laid the foundation of the particular body. They are incorporated in a given name because they are appropriate symbols in our diction to the main object. Now, unfortunately, some use these letter combinations of the alphabet BUT SELECT THOSE ANIMALS THEY WILL PROTECT. If an animal cannot look to an organisation professing to protect it, then where does it seek PRENENTION OF CRUELTY? I am afraid that some humane groups, particularly those who receive large contributions through Wills and bequests, are subject to infiltration by those who would countenance and turn a blind eye to vivisection. But time is catching up and to use Abe's famous words "You can fool some of the members all of the

THAT FIRST BRANCH OF THE TREE. As our organisation grows, so we gather those of like thought around us who in turn propogate our ideals and carry our message. I think it is true to say that if we can touch the heart strings of those who are compassionate and they pause to contemlate, their desire is to emulate. The Central Coast area is the first district in which the many have come together in our name and they were officially recognised on the 4th December, 1976, as "The Cat retection Society of N.S.W. The spark was generated by that ball of energy, Mrs. Derothy Haines, as Secretary, Kath Robinson as President, with Gwen Arnold as Treasurer, together with Zilla Cook, Glad Hagan and Doris Jackson making up the balance of Committee. a team with the loyal support of the local members, they are without doubt terrific in accomplishment - with 28 desexed, 13 euthanased, 63 found homes and a further 51 given vet treatment; the whole being financed by street stalls and raffles which are always on the go. have received marvellous support from the local press and radio, Umina Pet Centre, Umina Viewfinders Circle, Fay Saunders and that stalwart, Tanya Goodall in Camberra, and the very pleasing gesture of a donation of equipment from the Animal Welfare League, Northside branch; plusplus- too numerous to mention. As Dorothy says "We are softies and have 110 cases on our books at the start of the financial year in the Woy Wey Peninsula (Wey Wey, Ettaleng, Umina, Pearl Beach, Patenga) and have many calls from Wyong and Gosford Shires which we cannot handle." Sincere thanks and appreciation from Head Office to these selfless Girls" for spreading the name and fame of the C.P.S.

Parrish, M.B.E. with her stall; Bill and Judy Graham with the wine tasting; Bill Graham and Mrs. Haines with the Xmas bush; Dorothy Haines and the "Girls" at Woy Woy with various projects; and not forgetting that stupendous effort by Gordon and Sybil Cozens with their \$500 from the Annual Garden Party, April last and a Mannequin Parade at their Lane Cove home - Roz Baker ladies - then afternoon tea and a raffle of a camellia plant from Mrs. L. Haines completed the day for \$150 in kitty. Nice going, Sybil year when one reflects on the lack of such in the past.

ELECTION OF COMMITTEE AND SUB COMMITTEES. This will take place at the A.G.M. and the business acumen, skill and experience of those elected will reflect itself this time next year. So, if you have knowledge of legal matters, publicity, fund raising or general business and secretarial practice, do not wait to be nominated. Offer your skill to have a gathering of two people who accomplish things rather than twenty who are mostly dead wood and have nothing else to offer than talk.
