

PRESIDENT'S REPORT

As another Government takes the helm in NSW we await with renewed hope, mixed with a sprinkling of scepticism (having had our hopes dashed by so many previous Governments), to see if it will follow in the footsteps of the Victorian Government which recently passed cat control legislation. By the time you read this Journal we expect to have talked with the new Minister of Agriculture, the Hon. Richard Amery, M.P., whose portfolio embraces Animal Welfare.

At the end of May we were delighted to be visited by Dr Carole Webb, Executive Director of The Cat Protection Society of Victoria, who was accompanied by their treasurer, Mr Brian Parry. We were very interested to hear about their work, policies and experiences and especially about the changes taking place in Victoria following the passing of the Domestic Animals Act late last year. This Act gives cats protection under the law and sets out requirements for responsible ownership. The aim is to responsibly manage domestic cats and to reduce the unowned cat population. Cats will have a legal status for the first time.

Although this legislation will take about a year to implement, moves are already underway in local councils to have pet cats registered, desexed and provided with identification in the form of collar and tag or, preferably, micro chip. Like ourselves, the Cat Protection Society in Victoria will not sell any cats unless they are desexed, and they have had excellent results with the early desexing of kittens who recover very quickly. Early desexing is also gaining favour with the veterinary profession with ever increasing numbers of vets adopting this practice. We now dare to feel optimistic that eventually nearly every healthy, tame, homeless cat may be able to find a good home.

Councils throughout the Sydney metropolitan area are beginning to frame their own regulations to curb the indiscriminate breeding of cats and dogs, as well as other pets. For example, Hurstville Council recently adopted animal codes limiting the number of pets and livestock per property. Although their code restricts the number of cats to two without Council permission, they intend to be flexible with responsible owners. Naturally, they will be relying on complaints from neighbours, or other interested parties, to discover the irresponsible owners.

A big step forward in our campaign to reduce the numbers of unwanted cats in the community has been the early desexing of kittens which means that no cat or kitten is sold to the public undesexed. As other animal welfare organisations are now following this action, we trust that we will soon see a dramatic drop in the number of abandoned cats and litters picked up or brought into our welfare office. Also, we now microchip each cat before sale. This involves the vet implanting a tiny disc in the scruff of the neck with a syringe, a quick and relatively painless procedure. The disc has the cat's own identification number so that should the cat ever get lost, a vet or animal welfare agency has only to use a scanner to identify the owner and have the animal returned.

Our building at 103 Enmore Road is in urgent need of repair. This will be a costly job which will seriously deplete our resources. Added to the low level of legacies received in the year ended 31 May, 1995, we are having to dip into our investment capital to continue our operations. So we appeal to all our members to be as generous as possible with donations and to remember the Society when making Wills in order that we will not have to cut down on the help we can give the neglected moggies in this huge city.


MEMBERSHIP RENEWALS DUE NOW


OWN A WHISKER OF HISTORY



Lovingly, caringly, you greet me unaware of the frustrations


I have harboured this working day. Unconscious of my bedraggled appearance or the fine creases etched into my time-sodden makeup.



flick of her tail she's off on urgent realm business. (Courtesy 'Devon Rex Newsletter, Dec 1994)


FLOWERY FELINES

CAT CRAFT

If you're not a Michelangelo or Picasso, what can you do to emblazon your clothes or home with cats?. There are ideas galore for glorifying cats in stitches, paints, fabric, paper, and few require expensive equipment or reams of talent. Much of today's craftworld is geared to people who have never attempted to be creative because they are convinced they aren't. Modern technology and inspiration have put much on the market that anyone can tackle and produce a fine result. With the parameters of 'easy and inexpensive crafts with cat motifs', I entered the March Stitches & Craft Show.

ONE STEP DÉCOUPAGE

This has to be a winner on all counts. Materials are inexpensive,




leftovers can be used in normal day-to-day living and the finished product outstanding. Découpage is the processoflayering pieces of paper over a board or an objectandaffixing with glue to make a picture. It can be simple talented as you want. In this instance you are glorifying a cat stature. Materials

are 1 unglazedchina cat (\$7-\$18), 1 piece of printed rice paper (\$2.45), 1 bottle of PVA glue (\$2.40) and a brush (\$1). You cut or gently tear the rice paper into small pieces, brush glue on a small area of the statue, put a piece of rice paper over the spot and brush over with glue. The entire cat is done in this manner. The glue dries to the touch in 20 minutes, hardens overnight and gives a clear finish. If you want a shiny finish than get a can of The finished cat can be washed (but not soaked!) and will be a bright decoration in your home or cheer up a friend as a gift. One word of warning ... this could become addictive! Jow's Hobby Ceramics, 77 Love Street, Cessnock 2325 (049) 911 812 run a mail order business. You can also find supplies at china painting shops and newsagents. (Note: prices are approximate at time of printing.)

STAMP ART is a craft that is becoming quite popular. Make


your own stationery, cards and wrapping paper. There is a wide range of stamp designs available as well as an amazing range coloured and multicoloured stamp pads and additives to make designs multi coloured, embossed or



glittery. Special scissors let you cut decorative edges. New enhancements are coming out all the time and there is no limit to what you can do with stamps. A word of caution, what is cheap is not necessarily good. You can buy stamps at prices well below those you see in the stamp specialist shops - and for good reason. The stamp may not be as finely cut but, more importantly, the sponge pad between the stamp and the wooden block is usually quite thin which means, even with the greatest care, you print the block outline as well as the design you want. Not a pretty sight. Art Stamps Australia at 342 Military Rd, Cremorne has an excellent range and also gives classes.

FABRIC PAINTING Turn a Target T Shirt into a Double Bay Designer item. You can't paint a cat, you say? Go to your newsagent and pick a wrapping paper with a nice cat motif, carefully cut the cats out, secure it to your T Shirt with a light


adhesive spray glue andworkyourdesign around it. Īπ 'Midnight Cats' the window opening was cut out of paper and fixed to the dark T-shirt. Narrow masking tape was used to make the window bars and the cats were cut out from wrapping paper. No need to draw a thing. The nightskywaspainted on the fabric with Phoenix Acrylic Flat range, mixed into



Phoenix Pearliser for soft pearl tints. The paint was brushed onto the fabric with downward strokes until the entire area in the window was complete. When the pattern pieces were removed a wonderful design of three cats silhouetted in a window appeared. Phoenix Fabric Paints are a cold cure formulation so they do not require heat setting. They are Australian made and available through a network of Phoenix instructors. Phoenix Fabric Art, 31 Chiltern Court, Nambour Qld. Ring (074) 41 2336 or Tom Duffy on 045 66 4493 for local suppliers and instructors.

FOLK ART PAINTING can be as complex or simple as your prefer. Cat door stops come in two designs, a cheeky Fat Cat and a sleek Siamese. The cats are made from craft wood and cost about \$20 plus about \$5 for paint. Paint cost will be higher if you use many colours for a more naturalistic cat. You can paint a fun cat, a Tuxedo Cat in immaculate Black and White, or use a bit more artistry to create a tabby with tabby marking and fur lines - you can be so basic that you paint a plain cat and buy two of the moveable eyes from a button place and glue them on. However you decorate your doorstop it will bring fun and pride working on it and joy when your friends note your artistic ability. Two nice doorstop cats are available from Elsa's Folk Art Studio, 12 Myrtle St, Normanhurst (02) 484 5447. You can select your own and take advantage of her classes or buy by mail order.

NEEDLEWORK Cats have appeared in needlework since women first began stitching and there are cat designs galore in any media. You can buy prepainted canvas for needlework or cross stitch or work from a graph. These are a few of the many cat kits available. Works range from 2" x 2" up to much a grander scale and the range of designs can be chosen to suit children, the elderly, beginners as well as the very experienced. Stadia Handicrafts, 87 Elizabeth St, Paddington. Stadia also has a very nice range of boutique cat buttons that can liven up any outfit.



TRI CHEM FABRIC PAINTING Hey, cats are now welcome everywhere! That's right, cats can now be taken to shops, theatres, restaurants. Humans who take their furry friends around with them are regarded as real cool.




How? Well, apparently it's very easy. All humans have to do is paint up an easy iron cat transfer on a top, shirt or garment, using the world's leading brand of fabric and craft paints. Just imagine how beaut they can look with one of us draped around their shoulder or chest-no wonder so many are giving this craze a go. Tri-Chem's extensive range of oil and acrylic paints are non-toxic and come in small tubes which are as easy to use as holding a pencil. That's why even humans can't get it wrong. Mind you, some back off because they think they're not artistic - as if fabric painting was a big deal. They should try pussy footing along the fence or running up a tree. From what I hear, those who have done it are as happy as if they just finished off

a tuna lunch!

There are a lot of transfers to choose from - Kitten and the Rose, Back and Front Cats, Egyptian Cat Motifs, Cat and Paws Stencil. 



CAT GROOMING

So you have this lovely little furry ball of fluff that's cute and cuddly. Adorable, isn't it, the way it bites your fingers and plays with the brush. But wait! What's this one year down the track, a matted smelly bundle of hair that goes berserk if you show it a brush. Where did the cute kitten go?!?

Well, of course not all of the stories end up this way but you would be surprised how many turn up and need help.

What to do to prevent this in the first place? Well DON'T allow your kitten to bite you when you brush and comb it! That may be cute, but an adult cat biting isn't! So be firm but gentle and be VERY PERSISTENT. This is going to take time but you will win if you try. Try to make each session short at first. After all, there won't be much to brush but you are getting your kitten into a habit of being brushed. Once you have established a routine and your cat is used to it, then you can pay more attention to the actual work that you're doing. Make sure you comb through all the cat, especially under the front legs and between the back legs. These are areas that get neglected because they are quite difficult to do. I say comb because that is your most important piece of equipment. With a comb you can get right to the skin and make sure all the knots are out. Brush afterwards to give a bloom to the coat.

What to do if you have missed out on the kitten training stage and have a knotted cat?

Either the vet or a GOOD groomer are quite likely your best answer. Please don't ever use scissors to cut knots away. You can do untold damage as cat skin is very loose and delicate and I have seen cats with horrific slices from owners who tried to cut away the matts and sliced away part of the cat instead. If your cat is a real mess the best way is to get your vet or a groomer to clip the hair completely away. This can look very odd but it does let you start again and this time you should be able to keep it under control.

Have you cat professionally groomed about every 6 - 8 weeks if you can if you are having trouble with the coat. You can also have the areas under the tummy and under the back and front legs clipped off, this leaves the coat easier to deal with but doesn't spoil the appearance of your cat.

What do you look for in a groomer? Well, you are going to have to look long and hard because there are not too many of us around. A lot of salons will not handle cats or only will if they are sedated. I only do this as a last resort and EVERY cat gets one chance with me. Sometimes it helps if the owner stays and helps hold the cat. Be prepared to leave your cat for most of the day though, as I will give the cat a rest if it gets restless so this can add to the time required. My regulars don't take too long and I can usually give a time. Make sure that the premises are secure as cats are the world's best escapers. If you can, try to have a groomer recommended to you by someone who takes their cats there as this can be the best gauge.

I hope this has helped with a few knotty problems, good luck with your cats.

The necessity to suppress pet-loss grief for fear of adverse reaction is becoming a thing of the past. It is now strongly recognised by most people the role pets play in our lives and the strong grief and loss that occurs when they die or disappear. There are books on the subject, trained counsellors are available, and now The Australian Centre for Companion Animals in Society (ACCAS) has a Pet Loss Grief Support Hotline.

PET LOSS GRIEF HOT LINE

If you are struggling with your grief and you are not sure how to recover from your sad feelings, reach out - don't be alone with your grief - call (02) 746-1911 7pm-9pm. Whether your pet dies, is lost or stolen, or must be placed in a new home, the end of a special relationship with one's pet can be one of the most difficult times of our life. The people who staff the Hotline and Group understand this. These volunteers provide an outlet for people to express their feelings and concerns when faced with hard times involving their cherished animal companions because they have also experienced this grief on a personal level. It is their hope to comfort and give you compassionate support. It is envisioned that the Support Hotline and Support Group will become a pivotal source in providing the community with information concerning the nature of our relationships with companion animals.

IT'S OKAY TO TRULY LOVE YOUR PET

Pets offer unconditional love and companionship in an increasingly hectic, mercenary and lonely society. It is perfectly normal to form strong emotional bonds with our pets. Equally, it is totally normal for any pet owner to experience intense grief when a much loved pet dies or is euthanased. No one should dismiss a pet as 'just an animal' or play down the very real sadness that occurs when we lose a pet. Even for people who share their lives with many animals, every so often an extra special one comes along. When we must face the loss of an extraordinary animal companion, we may be shocked to find ourselves experiencing intense grief. It might even be worrisome to have an overwhelming response to losing 'just an animal'.

First and foremost, GIVE YOURSELF PERMISSION to have a reaction, whatever it is. Grief can occur before, during or after the loss of a loved one and can take many forms - numbness, anger, weepiness, hopelessness and more. Every loss is unique and every person grieves differently; no two losses are alike and grieving does not get any easier with experience. Without proper care and attention profound sadness and grief may last from a few weeks to many years. If a loss of this magnitude is new to you, you may feel as though you will never get over it and that you will be suffering forever. In every case, grief does not go away magically. Dealing with your loss and the passage of time are the two best healers.

Classically there are 5 Stages to Grief:

- 1 **Shock/Denial.** It is a natural protective mechanism to initially deny the reality of death.
- 2. Anger. This may be directed internally or at others.

Blaming or accusing others or oneself allows a chance to focus on an issue other than the loss.

- 3. **Guilt.** This is the phase of questioning "what more could I/ they have done?" "Could I have loved him or her better?"
- 4. **Depression.** This is the phase of true sadness as the reality of the loss is felt. Protracted and unresolved depression may require professional help to resolve.
- 5. Acceptance. This is the recovery stage when the death is more or less accepted. Fond memories occur and new emotional ties can be made.

Recovery from Grief; Tips for Self Care

You need to take extra good care of yourself and take one day at a time.

Talk only with people you feel understand you.

Get plenty of rest

Even if you are not hungry, eat something nutritious.

Drinking alcohol or using other drugs can intensify feelings of depression.

Wash your face and brush your teeth: this will help you feel refreshed.



BOARDING PRELIMINARIES

Well now you're all set for your holidays. Tickets and hotels booked, cases packed. Hang on! What about the cat? What are you going to do with puss for the duration? Well, one option is to board. Oh No! I hear you cry. Not one of those dreadfully smelly places with little cages. No! Not one of those. There are much more pleasant catteries around now that offer much better facilities for your cat. So take the time to go and visit BEFORE you need to use one.

What basics should you look for?

Cleanliness above all else. No smelly dark cages. They should be well lit and airy. This is most important as a good air flow is paramount to keeping cats healthy. Make sure the cats can't sniff each other directly through the wire. This can be the way cat fluis passed on. The requirements for boarding a cat are that the cage should measure a minimum .9m x .9m x .9 m so check that they are big enough. By the way, this is not a large area.


Check that the litter trays seem to have been cleaned that day. Remember that a playful cat can make a terrible mess in no time flat but there is a difference between today's clean and last week's clean. Check to see that there is a clean water supply. Cats don't drink much but it must be clean. Check to see if the food is fresh. Ask what foods are available. Avoid places that only give dry foods to cats. This can have a bad effect over a long period.

That's their end - now what do you need to do?

First, and most important, keep your cat's vaccination up to date, i.e., yearly, and keep the card where you can find it. Catteries are required to sight proof of vaccination and are within their rights to refuse admission if you can't provide it. Secondly, try to get your cat to eat a variety of foods. Some cats go quite strange over food and it can drive the cattery batty trying to get a reluctant eater started. Make sure that your cat is flea free before you take it for boarding as it is not fair to the other boarders if your cats starts them all itching. If your cat is on medication make sure you label it clearly and make sure your cat can be handled to take it. Nothing is worse than having to have a daily scratch and bite battle with a reluctant cat.

That's about all you have to do except make sure you book as far in advance as possible because the good places fill up fast at peak times. You'll find some catteries offer a lot more than the basics so if possible take a day to travel around and have a look. You might have to travel a fair distance to find the best place - but you cat's worth it, isn't it?

Homoeopathy is a system of medical therapy that concentrates on the whole being - animal or person - by methods that are gentle and sympathetic to the body's needs. It developed from investigations carried out in the 18th century by a German physician, Dr Samuel Hahnemann, who discovered the basic principle of homoeopathy:

This principle is: 'Like is cured by Like' or Similia Similibus Curantur. Hahnemann noted certain similarities between symptoms produced by some diseases and by the drugs used to treat them. He experimented on himself with Peruvian Bark, which produced in him all the symptoms of malaria. On the other hand, Peruvian Bark (a source of quinine) was then used with some success to cure malaria. He followed up his original observations and experimented on his colleagues, and himself.

He formed this theory: A disease can be cured by whatever medicine produces similar symptoms when given to a healthy animal/person. Called The Law of Similars, its beauty is that the treatment provided goes with rather than against the body's own efforts to regain health. The specially prepared substances used as remedies in homoeopathy contain minute doses of herbs, minerals, animal products such as bee venom and cuttlefish ink, and various other products.

These substances are diluted so that only minuscule amounts actually enter a patient's body. Sometimes dilution is so extreme that it goes far beyond the point where the substance could act through molecular strength. While there is much debate how these greatly diluted substances actually do work, many homoeopaths believe that they carry information derived from the original material, while others believe magnetic forces come into play. Strange as it may seem, the higher the dilution, the more potent the remedy is.

We know a bee sting will cause a certain typical reaction, including swelling, fluid accumulation, redness of the skin, pain and soreness, that is accentuated by the application of heat or pressure. If a homoeopathically prepared dilute solution of bee venom is given to a person or animal with these symptoms - even if they are caused by something other than a bee sting the condition will clear up. The essential feature is that there be close similarity between the remedy and the condition for it to work properly.

The medicinal effect is thought to be like this: When the body is disturbed (diseased) the symptoms manifested are its attempts to heal and restore balance. We know, for instance, that inflammation with redness, pain and swelling are primary defence tactics of the body. Therefore the affected part is particularly sensitive to the action of a matching remedy, which acts like a catalyst or booster to the self healing process. Standard drugs, by comparison, are generally used either to

take the place of normal body processes (hormonal drugs), inhibit body responses (painkillers, anti-inflammatory antihistamines) or weaken or kill bacteria or cancer cells (antibiotics, chemotherapy, radiation therapy). Homoeopaths, on the other hand, consider that the individual has only one disorder, which can create many symptoms and idiosyncratic characteristics. Therefore, only one remedy is administered at a time-the

one thought to be the best catalyst for the body's total defence response.

Nowadays, homoeopathic treatment is widely used and recognised all over Europe (Britain's Royal family have long supported homoeopathy) and about every 4th German veterinary surgeon uses homoeopathic treatment complementary to western orthodox medicine.

What can be treated with homoeopathy?


- Common infections (by boosting the immune system)
- allergies like dermatitis, eczema, asthma
- arthritis, incorrect bone metabolism
- intestinal problems like diarrhoea, flatulence

- sterility, when pathological causes are eliminated

Veterinary homoeopathy does not mean the end of common sense practices as fluid therapy, nutritional therapy, surgical therapy, animal nursing and management and can be used in conjunction with conventional therapy.

There is no room for dogma in medicine if one is not to be guilty of neglect of one's duties to patients.

Other therapies, too, can be brought in where considered helpful, e.g., Acupuncture, Herbalism, Osteopathy, Chiropractic, Magnetic, Ultrasonic and Electric therapy etc.

All may have a place from time to time and the byword of the ethical physician, whether human or veterinary, must be open mindedness

WHAT GOES IN HAS TO COME OUT

or 'what happens to the food I feed my cat before it gets to the litter tray?"

Cats, like all living things, convert food to energy. The most simplistic definition of life involves only that, but our cats are much more complex. Another sound byte definition is that all living things are solar-powered - which I think is a more obvious definition of life as our cats perceive it! So, we feed our cats, they sleep and play, and they use the litter tray. In order to keep the system working there are some pretty amazing things going on inside that coat, involving the intestines, the liver and the kidneys.

Food for cats has not always come packaged in tins or paper bags. It was clothed in fur, presented at body temperature, and required some effort to obtain. Ten mice a day is considered to be the ideal food ration for a cat, and their various body systems (teeth, eyes, ears, muscular co-ordination and digestive system) have evolved to acquire, consume, metabolise and excrete little rodents! However, this is not about the specifics of food requirements, it is about how the cat digests the food and the body systems involved in processing it thereafter.


A nutrient is any food constituent which helps support life and can have one or more of the following functions - they can form part of the body tissue itself, be involved in metabolism (the chemical reactions within the body), transport things throughout the body, regulate temperature, affect palatability or supply energy. Seems so simple. And there are actually only 6 groups of nutrients; water (the major one as it does all of the above jobs except supply energy); carbohydrates, fats and proteins (which provide energy and material to build body tissue); vitamins and minerals (which are used in the metabolic and chemical processes required by living organisms).

In fact, 50% - 80% of the food a cat eats is turned into energy, and that always ends up as heat — either directly produced to keep the cat's body temperature at about 38.5C, or as play and activity which heats up the air! Diagrammatically the whole thing goes like this

Food molecules (amino acids, sugars, fats, vitamins and minerals) in the blood go to the liver directly in order to be filtered and processed. The liver has a very complex blood supply and defensive immune system in order to protect the rest of the body from the toxins and inappropriate substances which are also absorbed by the intestines. It also acts as the processing plant to apportion the amount of proteins, hormone structures, glucose and fat required for other organs in the body to function or repair themselves. The sum total of these metabolic processes, at the end of the line, convert carbohydrates and fats (even those that started as proteins elsewhere) into carbon dioxide and water. The CO2 goes out via the lungs, and the water via the kidneys, taking along the leftover remnants of metabolism (such as urea, minerals and used water soluble vitamins) as urine. Other waste products are dissolved in the bile which the liver produces and exits via the bile duct into the small intestine and thence into the large intestine.

The energy released by these chemical processes is used by the cat in its day to day routine of organising her owner to feed her, let her out, find a sunny spot, etc. Never one to waste energy, the cat's liver can save the excess energy as fat and glycogen, stored in various parts of the body. The pad of fat in the groin is the equivalent of the camel's hump, because when the cat needs it, the liver converts the fat back into carbon dioxide, water and energy. No cat ever takes a chance on its next meal - no matter how devoted the owner, they always have a little stored away in case of a missed mealtime!!

The liver is the incoming filter, nutrient processor and elicitor. The kidneys are the outgoing filter and get rid of all the left overs which are water soluble. Rather than select the stuff it wants to get rid of, the kidney filters everything out of the blood except for the red blood cells and plasma proteins, then takes back what is wanted via a complex system of exchange



So what goes in has to come out - and all of it to provide energy for playtime and purring!

The digestive processes are applied to the meal, starting with saliva in the mouth, acid in the stomach and enzymes in the small intestine. When these are finished with the food, it has been broken down into molecules small enough for the cells lining the intestine to absorb, and thence dissolve into the blood to be taken to the liver. So everything not absorbed by the small intestine is now waste material, and is carried on to the large intestine where bacteria live, where some of the remaining water is absorbed and thence into the litter tray or the garden as faeces.

mechanisms. Occasionally it gets tricked, but mostly the kidneys do a great job, and produce a very concentrated urine (a reminder of the early evolution of the cats as desert creatures). Some cats are prone to cystitis (bladder inflammation), and there is considerable research going on in this area to determine why and what is the best way to prevent and treat it. Meanwhile, most cats have no problems with the strength and consistency of the urine they produce.

So now everything that went into the cat as nutrients has come out either as CO2 from the lungs, or deposits in the litter tray or as the heat of activity of living (and cats really are good miniradiators). Next time you see her sitting on the shelf in the pool of warmth remember - if you think the sun shies out of your cat, you're technically right!


